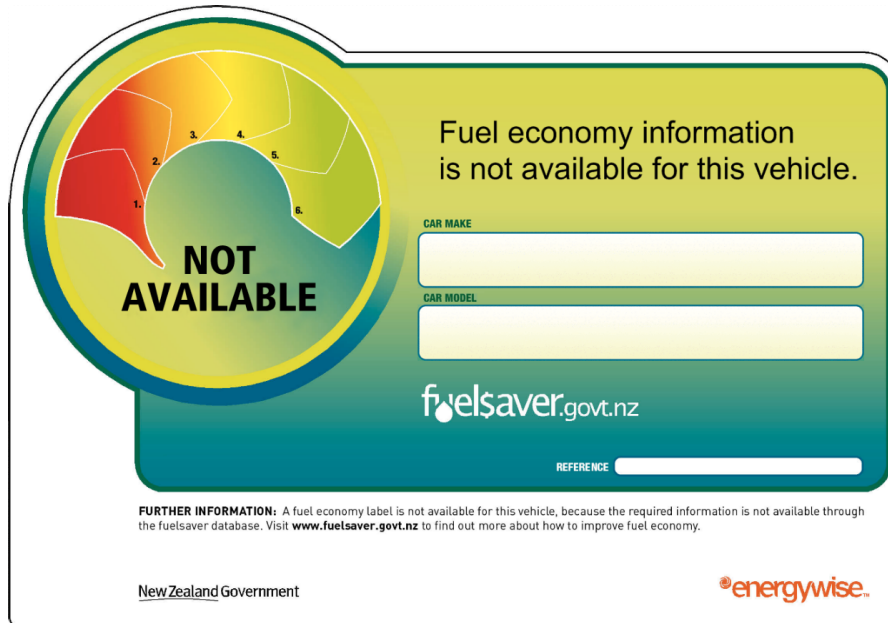

If the seller states that the loan has been repaid then ask the seller to obtain confirmation from the secured party that the loan has been fully repaid and that the secured party will remove their registered interest. Sometimes a registered security interest relates to a previous owner. It should be the responsibility of the seller to sort this out. In this situation the seller may be able to talk directly to the secured party to explain the situation. The secured party will usually be able to confirm whether there is money owing or not. If there is not then the seller should ask them to remove their interest.
